to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged); have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Henry C. Harding, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown and designated as Lot No. 10 of Indian Hills, plat of which is recorded in the RMC office for Greenville County in plat book QQ at page 11, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on Hiwassee Drive at the joint front corner of Lots 10 and 11, and running thence with the line of said lots N. 80-30 E., 175 feet; thence S. 9-30 E., 62.2 feet; thence S. 59-30 W., 155.3 feet to a point on Hiwassee Drive; thence with Hiwassee Drive N. 30-30 W., 43 feet to bend; thence still with Hiwassee Drive N. 20-00 W., 78.5 feet to the point of beginning.

The foregoing conveyance is made subject to the recorded restrictions applicable to Indian Hills and the drainage easements as shown on said plat.
