TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND FOUR HUNDRED AND NO/100 - (\$1,400.00) - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. P. MEDLOCK, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 6 of the property of W. T. Patrick and William R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 131, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Salem Court at the joint front corner of Lots 6 and 7 and running thence S 34-20 E 142.7 feet to a point at the rear corner of Lot 7; thence S 20-17 E 41.2 feet to a point; thence S 55-40 W 70 feet to a point at the joint rear corner of Lots 5 and 6; thence N 34-20 W 174.8 feet to a point on the Southeastern side of a turnaround at the Southwestern end of Salem Court; thence with the Southeastern side of said turnaround N 00-55 E 9.7 feet to a point; thence with the Southeastern side of Salem Court N 55-40 E 74.4 feet to the point of beginning.
