

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being on Redwood Drive and being known and designated as Lot No. 11 of Subdivision No. 1 of Property of W. H. Hendrix as shown on plat thereof · recorded in the R. M. C. Office for Greenville County in Plat Book "HH", Page 31, and having, according to said plat, the following metes and bounds, to-wit:
