Know All Men by These Presents:

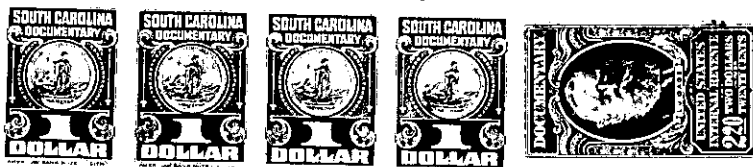

Costner, his heirs and assigns,

All that certain piece, parcel and lot of land lying and being in Gantt Township, County of Greenville, State of South Carolina, near the City of Greenville, lying and being in that certain subdivision known as "Belle Meade", being owned by Derby Heights Inc. shown as Lot No. 195 according to a plat made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "EE" at Pages 116 and 117, and being more particularly described as follows:

BEGINNING at an iron pin on the north side of Camden Lane and running along the line of Lot 196 N. 17-45 W. 145.2 feet to an iron pin, joint rear corner of Lots 195 and 196; thence S. 61-42 W. 96.1 feet to an iron pin, joint rear corner of Lots 194 and 195; thence along the line of Lot 194 S. 27-45 E. 142.5 feet to an iron pin on Camden Lane, joint front corner of Lots 194 and 195; thence along Camden Lane N. 61-42 E. 70 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions, and the easements reserved therein as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 505, at Page 73, as amended in Deed Book 521, Page 199.

The grantee is to pay 1958 taxes.
