to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ANN EVANS TATHAM, her heirs and assigns forever,

ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Northeastern side of Mable Avenue and being shown as LOT NO. 86 on Plat # 2 of the property of James M. Edwards; recorded in the RMC Office for Greenville County in Plat Book II, at page 120 and having, according to said Plat, the following metes and bounds, to wit:
