McCLURE, JR. AND BERNICE P. McCLURE, their heirs and assigns, forever:

ALL that lot of land, with the buildings and improvements thereon, situate on the Northeast side of Lisa Drive, near the City of Greenville, in Greenville County, S. C., shown as Lot 44 on Plat of Wade Hampton Terrace, made by Dalton & Neves, Engineers, March 1955, recorded in the RMC Office for Greenville County, S. 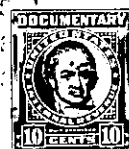
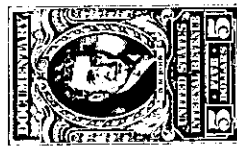
