Know All Men by these Presents:

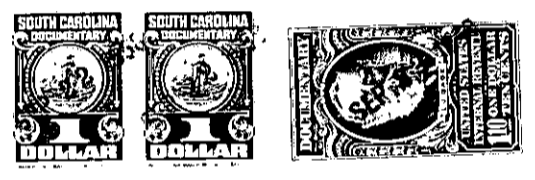
That I, Florrie V. Greer in the State aforesaid, in consideration of the sum of Ten (\$10.00) Dollars and other consideration DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Levis L. Gilstrap, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, on the southeast side of Greenbrier Drive being shown and designated as Lot No. 5 on a plat of Greenbrier Subdivision, made by Charles F. Wells September, 1957, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Greenbrier Drive at the joint front corner of Lots Nos. 5 and 6, and running thence with the line of Lot No. 6 S. 35-30 E. 235.5 feet to pin; thence N. 51-48 E. 100.1 feet to iron pin; rear corner of Lot No. 5; thence with the line of Lot No. 5 N. 35-30 W. 230.8 feet to pin on Greenbrier Drive; thence with the southeast side of Greenbrier Drive S. 54-30 W. 100 feet to the point of beginning.

It is understood that this conveyance is made subject to restrictive covenants duly recorded and applicable to all lots in said subdivision.
