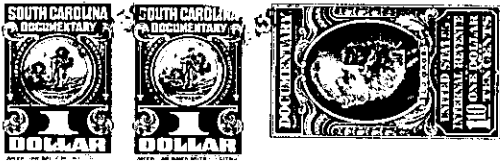

Highway no. 288, being shown as Lots seven (7) and eight (8) on plats of survey of same made by C. Edgar Williams, Jr., surveyor, September 29, 1954, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:

Lot no. Seven (7):

BEGINNING at a stake on the East bank of said river 485.4 feet North of the Guest-Ellison property corner and running with the river N 85-27 E 66 feet to a stake; thence with the river N 78-18 E 61.3 feet to a stake; thence S 8-43 E 69.5 feet to a stake; thence S 84-18 E 53 feet to a stake; thence S 81 W 55 feet to a stake on road R/W; thence N 28-30 W 63 feet to the beginning corner.

Lot no. Eight (8):

BEGINNING at a stake on the East bank of said river 612.7 feet North of the Guest-Ellison property corner and running with the river N 80 E 90 feet to a stake; thence S 21 E 49.4 feet to a stake; thence S 68-33 W 104 feet to a stake; thence N 8-43 W 69.5 feet to the beginning corner.
