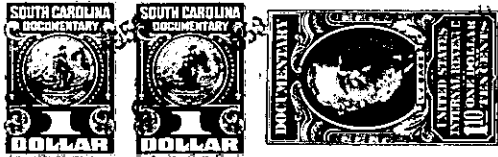
That JAMES A. WILSON, in the State aforesaid,

BEGINNING at a concrete monument on the southern side of the turn around above referred to which point is 624 feet more or less northeast of the intersection of New Street with Washington Road and running thence with the curve of the southern side of said turn around, the chord of which is N. 70-03 E. 62.4 feet to an iron pin at the front corner of Lot 3; thence with the line of said lot S. 57-49 E. 97.6 feet to an iron pin; thence S. 41-03 W. 70 feet to an iron pin; thence N. 47-20 W. 132.4 feet to the beginning corner.
