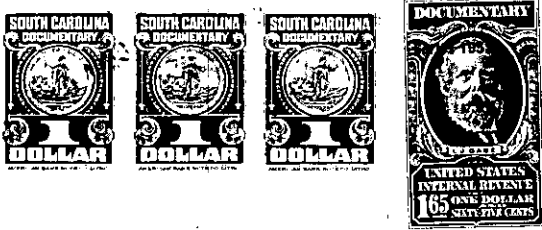
That I, Annie B. V. P. Gardner, in the State aforesaid,

All that piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, on the north side of Oakland Drive in the City of Greenville, and having the following metes and bounds according to a plat made by C. C. Jones and Associates, Engineers, on September 30, 1958:

BEGINNING at a point on Oakland Drive 150 feet from Keith Drive and running thence S. 8-28 E 157.4 feet to an iron pin; thence N. 67-45 E. 116.8 feet to an iron pin; thence N. 22-15 W. 153.9 feet to an iron pin on Oakland Drive; thence along Oakland Drive S. 67-45 W. 80 feet to the point of beginning.
