That I, Floyd Hunt in the State aforesaid, in consideration of the sum of One and 00/100 (\$1.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Alice Hunt, her heirs and assigns, forever:

all of my one-half (1/2) interest, right, title and ownership in and to that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, being known and designated as Lot no. 24 of a subdivision of the property of E. S. Bulman as shown on a plat thereof made by J. C. Hill, dated September 24, 1949 and recorded in the R.M.C. Office for Greenville County in Plat Book Y, at page 19, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Chestnut Ridge Road at the corner of Lot no. 23 and running thence along the line of that lot S 49-30 E 346 feet to an iron pin; thence S 58-30 W 116.4 feet to an iron pin at the rear corner of Lot no. 25; thence along the line of that lot N 49-15 W 283 feet to an iron pin at the corner of said lot in the center of Chestnut Ridge Road; thence along the center of said Chestnut Ridge Road N 28-30 E 100 feet to the beginning corner.

The above described property is all of the same conveyed to Floyd Hunt and Alice Hunt by deed of Anna Orene Bulman, August 9, 1955, recorded in the R.M.C. Office for Greenville County in Book 533, page 228, and this instrument is intended to convey the interest of Floyd Hunt to Alice Hunt.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
