M. Cook and Elizabeth Jane Cook, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as Lot No. 12, as shown on a Plat of Brookwood, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Cambridge Drive, joint front corners of lots 11 and 12 and running thence with joint line of said lots, N. 2-15 E. 165 feet to iron pin at rear corner of lots 50 and 51; thence running with rear line of Lot 50, N. 87-45 W. 100 feet to iron pin, corner of lot 13; thence running with line of said lot, S. 2-15 W. 165 feet to iron pin on Cambridge Drive; thence running with said Drive, S. 87-45 E. 100 feet to iron pin at point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.
