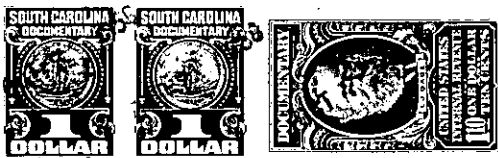
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. F. Brewer, James Carver, and Joe Vaughn, as Trustees for Maple Heights Baptist Church, an unincorporated religious association, their successors in office forever,

ALL that piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, South Carolina, being shown as Lot No. 1 on plat made by C. C. Jones and Associates, August 22, 1956, recorded in Plat Book NN, page 189, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING in the center of an unnamed street at the intersection of Oakland and running thence with the center of said unnamed Street N. 58-30 E. 100 feet to joint front corner of Lots Nos. 1 and 2; thence with the line of said Lots S. 28-30 E. 110 feet; thence S. 31-13 W. 106.3 feet to a point on the Easterly side of Oakland Drive; thence with Oakland Drive N. 25-12 110 feet to the point of beginning, and being a portion of the property conveyed to Grantor by deed recorded in the RMC office for Greenville County, S. C., by deed of Howard R. Fleming, dated October 30, 1957, and recorded in Deed Book 587 at page 156.
