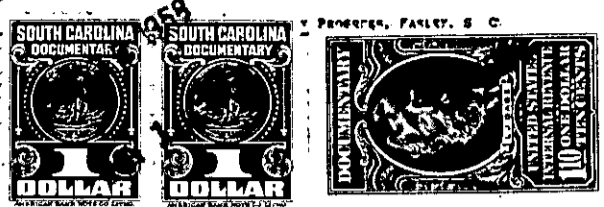

have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Taber, his Heirs and Assigns:

All that piece, parcel or lot of land situate, lying or being in Gantt Township, Greenville County, South Carolina, and according to plat of Sarah M. McWhite Estate, made by C. C. Jones, R. E., October, 1931, revised July 7, 1932, recorded in Plat Book FF at Page 22, having the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Old Piedmont Highway, corner of lot of W. M. McWhite, and running thence with the line of said lot S. 82-40 W., 299.9 feet to the right of way of the P. & N. Railway; thence with said right of way S. 12-50 E., 457.4 feet; thence N. 68-30 E., 299.5 feet to the center of Old Piedmont Highway, thence with the center of said Highway N.-13-22 W., 283.7 feet; thence continuing with said Highway N. 15-43 W., 100 feet to the point of beginning, containing 3.10 acres, and being the lot specifically devised to Grantee by the will of Sarah Mackey McWhite, filed in the Probate Court in Apt. 563, File 2.

William Taber Heirs and Assigns, against Me (~~Us~~) and My (~~Own~~) Heirs and against every person whomsoever lawfully claiming, or to claim, the same or any part thereof.
