to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

COURTNEY P. HOLLAND, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Greenville Township, being known and designated as LOT NO. 38 on Chelsea Circle and being shown on plat of Subdivision known as KIRKWOOD HEIGHTS, according to a Survey made by Pickell & Pickell, Engrs. October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE, at pages 110 and 111 and having the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lots 39 and 38 on Chelsea Circle and running thence along the joint line of said lots, South 17-56 East 150 feet to an iron pin; running thence North 72-04 West 27 feet to an iron pin; running thence North 65-05 East 41.7 feet to rear joint corner of Lots 38 and 37; running thence along the joint line of said lots, North 16-03 West 144.7 feet to an iron pin on Chelsea Circle; running thence along Chelsea Circle, South 72-04 West 73 feet to the point of beginning.
