Know All Men by These Presents:

That We, Walter S. Griffin, Walter W. Goldsmith & R. M. Caine in the State aforesaid, in consideration of the sum of One Thousand Four Hundred Seventy and no/100 (\$1470.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said D. U. Mauldin

ALL That certain piece, parcel or lot of land situate in the County of Greenville, State of South Carolina near the City of Greenville on the East side of Ridgeway Drive, being shown and designated as Lot No. 8 on plat of property of Waler Griffin; et al prepared by Piedmont Engineering Service on February 28, 1957, revised April 10, 1958, and having according to said plat the following metes and bounds:

BEGINNING At a point on the Eastern side of Ridgeway Drive, joint front corner of Lots 7 and 8 and running thence along the joint line of said lots S. 75-17 E. 140 feet to an iron pin at the joint rear corner of said lots; thence N. 14-43 W. 70 feet to an iron pin, joint rear corner of Lots 8 and 9; thence along the common line of said lots N. 75-17 W. 140 feet to an iron pin, joint front corner of said lots on the Eastern side of Ridgeway Drive; thence along the Eastern side of Ridgeway Drive S. 14-43 W. 70 feet to an iron pin at the point of beginning.

Subject to the following restrictions: (1) Said lot shall be used for residential purposes only. (2) Said dwelling shall be a single family residence only, containing not less than 1,000 square feet of floor space, excluding porches and breezeways. (3) No residence shall be constructed less than 40 feet from the edge of said street. These restrictions shall be for the benefit of and apply only to Lots 1 through 14, inclusive, as shown on said plat.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(s) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
