All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, located near the City Limits of Greer, S. C., located on the Northwest side of Lee Circle and being shown as all of lots SEVENTEEN (17), EIGHTEEN (18) and NINETEEN (19) on a plat entitled "MAPLE HEIGHTS" made for Lee G. Smith Estate by H. S. Brockman, surveyor, dated, Aug. 29, 1958, and recorded in plat book MM page 31, Greenville County R. M. C. Office and having the following outside boundaries, to wit:

Beginning at a stake on the Northwest side of said Lee Circle at the joint front corner of lots 19 and 20 and runs thence N. 30-15 E., 210 feet along the said Lee Circle to a stake at the near front corner of lots 17 and 18; thence N. 32-56 E., 104.5 feet still with the edge of Lee Circle to a stake at the joint front corner of lots 16 and 17; thence N. 57-49 W., 214.2 feet as the common line of lots 16 and 17 to a point on the line of the Howard property; thence S. 38-02 W., 333 feet along the line of the Howard property to the joint rear corner of lots 19 and 20; thence S. 61-34 E., 254.3 feet as the common line of lots 19 and 20 to the beginning corner.
