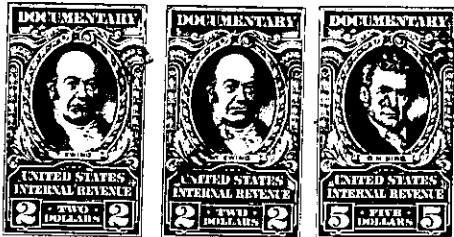
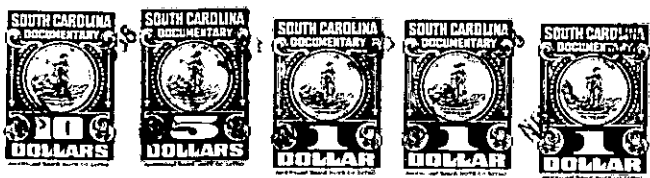
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roy Lewis Haskett, his Heirs and Assigns:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 20 Neal Circle, Plat of North Acres, which plat is recorded in the RMC Office for Greenville County in Plat Book EE, pages 12 and 13, and having, according to said plat, the following metes and bounds, to wit:
