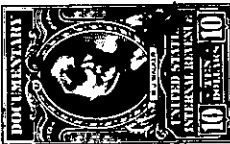

KNOW ALL MEN BY THESE PRESENTS That EUGENE RACKLEY

in the State aforesaid,

in consideration of the sum of Nine Thousand Six Hundred and No/100ths (\$9,600.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto CHARLES D. POWERS:

All that piece, parcel or lot of land situate, lying and being on the North-eastern side of Parker Road near Monaghan Mills in the County of Greenville, State of South Carolina, and known and designated as Lot No. 17 as shown on a plat entitled "Monaghan Subdivision, Greenville, S.C." made by Piedmont Engineering Service, Greenville, S.C., August 9, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Parker Road at the joint front corner of Lots Nos. 16 and 17, and running thence with the line of Lot No. 16 N. 38-30 E. 135.8 feet to an iron pin in the line of Lot No. 15; thence with the lines of Lots Nos. 15 and 19 N. 45-36 W. 90.2 feet to an iron pin at the joint rear corner of Lots Nos. 18 and 17; thence with the line of Lot No. 18 S. 38-30 W. 145.2 feet to an iron pin on the Northeastern side of Parker Road; thence with the Northeastern side of Parker Road S. 51-30 E. 90 feet to the point of beginning.

This is the identical property conveyed to the grantor herein by deed of J.P. Stevens & Co., Inc., dated November 10, 1958, and recorded in the R.M.C. Office for Greenville County, South Carolina in Deed Book 610 at page 291.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R.M.C. Office for Greenville County in Deed Book 509 at page 443, and to an easement for utilities service dated October 11, 1954, given by J.P. Stevens & Co., Inc. to Duke Power Company and recorded in the R.M.C. Office for Greenville County in Deed Book 510 at page 317.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
