A TRACT of 22 acres lying west of Geer Highway in the Town of Marietta in the rear of the property of Jarrard Hardware Company.

A TRACT of 8 acres on the southern side of Midway Drive in the Town of Marietta.

A TRACT of 10 acres on the eastern side of Geer Highway bounded on the south by Midway Drive, on the north by Ellen Street, and known as the Daisy B. Cleveland homeplace.

A TRACT of 7 acres on the north side of Ellen Street just east from Geer Highway bounded on the north by G. &amp; N. Railroad.
