Steading and Marjorie C. Steading, their heirs and assigns:

All that piece, parcel or lot of land situate, lying and being on the southeasterly side of Wedgewood Drive near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 18, Plat of North Meadow Heights, which plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book W, page 183, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeasterly side of Wedgewood Drive at a point 90 feet southwest of the southerly corner of the intersection of Wedgewood Drive and Green Meadow Lane, joint front corner Lots 6 and 18, and running thence along the joint line of said lots S. 27-46 E. 127 feet to an iron pin on the line of Lot No. 7; thence along the joint line of Lots 7 and 18 S. 52-37 W. 76.3 feet to an iron pin, joint corner Lots 7, 15, 17, and 18; thence along the joint line of Lots 17 and 18 N. 27-46 W. 140 feet to an iron pin on the southeasterly side of Wedgewood Drive; thence along the southeasterly side of Wedgewood Drive N. 62-14 E. 75 feet to the point of beginning.
