Cecil H. Fowler, his Heirs and Assigns forever:

All that certain piece, parcel or lots of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lots No. 9 and 10 of B. F. Reeves Subdivision in accordance with plat made by H. S. Brockman, dated September 14, 1958 and to be recorded in the R. M. C. Office for Greenville County, and being more fully described according to said plat, to-wit:

BEGINNING at an iron pin on the eastern side of Mayfield Road; joint front corner of lots No. 10 and 11, being 97 feet from the intersection of Mayfield Road and Gray Avenue, and running thence N. 69-10 E. 180 feet to iron pin; thence N. 20-50 W. 166 feet to iron pin; thence S. 69-10 W. 180 feet to iron pin on edge of Mayfield Road; thence along Mayfield Road S. 20-50 E. 166 feet to iron pin, being the point of beginning.

This being the same property as conveyed to the grantor by Deed of Cora E. League, recorded in Deed Book 555, page 84.

This conveyance being subject to all of the restrictions and conditions as contained in the Restrictions recorded in Deed Book 601, page 35, and Reference to said Restrictions is incorporated as a part and parcel of this Deed.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
