to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

James F. Julian and Nina C. Julian, their Heirs and Assigns forever:

All that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 30 of B. F. Reeves Subdivision in accordance with plat made by H. S. Brockman, dated September 14, 1958, and to be recorded in the R. M. C. Office for Greenville County, and being more fully described according to said plat, to-wit:

BEGINNING at an iron pin on the western side of Reeves Drive, joint front corner of lot No. 30 and Lot. No. 31; running thence along the line of Lot No. 31 S. 69-10 W. 180 feet to iron pin; thence S. 20-50 E. 83 feet to iron pin; thence N. 69-10 E. 180 feet to iron pin, thence N. 20-50 W. 83 feet. Said property being bound on the west by lot No. 5, on the north by Lot no. 31, on the east by Reeves Drive and on the south by Lot No. 29.

This being the same property as conveyed to the grantor by Deed of Cora B. League, recorded in Book 555, Page 84.

This conveyance being subject to all of the restrictions and conditions as contained in the Restrictions recorded in Deed Book 601, page 35, and reference to said Restrictions is incorporated as a part and parcel of this Deed.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
