OLLIE I. KNOW ALL MEN BY THESE PRESENTS:

That I, R. M. Caine, in the State aforesaid, in consideration of the sum of Fifteen Hundred and no/100 (\$1,500.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. J. Faress, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southwesterly side of Pine Creek Drive, near the City of Greenville, S. C., being shown as Lot No. 168 on the revised plat of Section C, Woodfields, as recorded in the RMC Office for Greenville County, S. C. in Plat Book W, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Pine Creek Drive at a point 199.9 feet southeast of the southerly corner of the intersection of Pine Creek Drive and Hillside Lane, said pin being the joint front corner of Lots 168 and 169, and running thence along the joint line of said lots S 33-28 W 130.7 feet to an iron pin; thence continuing with the line of said lots S 28-16 W 48.2 feet to an iron pin, joint rear corner of Lots 150, 152, 168 and 169; thence with the line of Lot 152 S 61-32 E 83.9 feet to an iron pin, joint rear corner of Lots 167 and 168; thence with the line of said lots N 33-28 E 170.2 feet to an iron pin on the southwesterly side of Pine Creek Drive; thence with the southwesterly side of said Drive N 56-32 W 90 feet to the point of beginning.

This is one of the lots conveyed to the grantor by the deed recorded in Deed Book 568, page 476.

This lot is conveyed subject to the restrictions, easements and rights-of-way of record in the RMC Office for Greenville County, S. C. This property is further conveyed subject to the following restrictive covenant: No dwelling shall be erected on the property herein conveyed containing less than 1300 square feet of floor space for a one story structure or less than 1000 square feet on the ground floor of a one story structure.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
