to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
W. L. BURGER, his heirs and assigns, forever:

ALL that lot of land situate on the East side of Harbor Drive and on the South side of Farr's Bridge Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 36 on Plat of Lake Harbor, made by Dalton & Neves, Engineers, May, 1958, recorded in the RMC Office for Greenville County, S.C., in Plat Book "MM", page 15, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Farr's Bridge Road at the joint corner of Lots 35 and 36, and running thence with the line of Lot 35, S. 21-34 E., 205.3 feet to an iron pin; thence S. 69-05 W., 130 feet to an iron pin on the East side of Harbor Drive; thence with the East side of Harbor Drive, N. 11-55 W., 183.8 feet to an iron pin; thence with the curve of Harbor Drive and Farr's Bridge Road (the chord being N. 28-50 E., 37.9 feet) to an iron pin on the South side of Farr's Bridge Road; thence with the curve of Farr's Bridge Road (the chord being N. 69-36 E., 70 feet) to the point of beginning.

THIS is a portion of the property conveyed to the Grantor herein by deed of Harold R. Turner, Jr., dated December 17, 1957, recorded in the RMC Office for Greenville County, S. C., in Deed Book 590, page 40, and this deed is made pursuant to the authority vested in me under said deed.

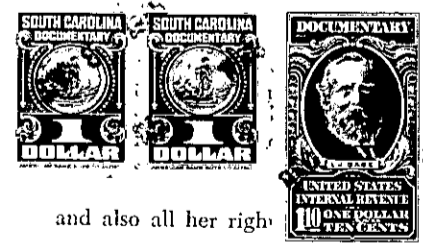
