BEGINNING at an iron pin on the Northern side of W. Elford Street, corner of property designated as Janie K. Vaughan and running thence with the North side of W. Elford Street, N. 6-24 W. 50.6 feet to an iron pin; thence with the line of property indicated on said plat as Hughes and Bartlett, N. 20-04 E. 94.5 feet to an iron pin; thence S. 64-01 E. 50.1 feet to an iron pin at the Northwest corner of property indicated on said plat as Janie K. Vaughan; thence with the line of said property, S. 20-04 W. 96.8 feet to an iron pin on the Northern side of W. Elford Street, the point of beginning.
