Parker and Doris Davis Parker, their heirs and assigns forever:

ALL that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, containing 29 acres, being a portion of Tract No. 1 of the Nellie H. Cason property as shown on plat thereof prepared by W. J. Riddle, Surveyor, July, 1945, and having, according to a plat prepared by C. C. Jones and Associates, October 17, 1955, the following metes and bounds, to-wit:
