KNOW ALL MEN BY THESE PRESENTS, That we, Alvin C. White and Sudie W. Massey

in the State aforesaid, in consideration of the sum of Five and no/100----- Dollars

to us in hand paid at and before the sealing of these presents by Faye White Henderson and John Clyde Henderson, Jr.

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Faye White Henderson and John Clyde Henderson, Jr., their heirs and assigns forever:

All our undivided right, title and interest in and to:

all that piece, parcel or lot of land in Austin Township,

County, State of South Carolina located on U. S. Highway No. 276, being known and designated as Tract No. 2, containing 2.76 acres according to a Survey made by C. O. Riddle of the property of C. C. White Estate, April 1953 and having the following metes and bounds, to-wit:

Beginning at an iron pin on U. S. S. Highway No. 276, the beginning corner.

Beginning at an iron pin in County Road at corner of Tract No. 5 and property now or formerly owned by Luke Forrester and running thence along said County Road, S. 73-03 W. 1268.8 feet to an iron pin in line of property now or formerly owned by Thomas Edwards; running thence S. 14-04 E. 1049.6 feet to an iron pin; running thence along joint line of tracts 3 and 5, N. 73-44 E. 869.4 feet to an iron pin; running thence N. 68-30 E. 386.4 feet to an iron pin; running thence N. 19-27 W. 488.5 feet to an iron pin; running thence N. 7-34 W. 546 feet to an iron pin; running thence N. 7-34 W. 19.2 feet to an iron pin, the beginning corner.
