Know All Men by These Presents:



That I, WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of TWO THOUSAND SEVEN HUNDRED FORTY-FIVE AND NO/100---DOLLARS, (\$2,745.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HAROLD N. PETTIT and ANN PETTIT, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 116 of a subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Richbourg Road at the joint corner of Lots 116 and 117 and running thence S 67-00 W 160 feet to a point at the joint rear corner of Lots 116 and 117; thence N 23-00 W 141.7 feet to a point on the Southeastern side of Beaufort Street at the joint corner of Lots 116 and 125; thence with the Southeastern side of Beaufort Street N 60-19 E 60.6 feet to a point; thence continuing with the Southeastern side of Beaufort Street N 67-00 E 85 feet to a point; thence following the curvature of the Southwestern intersection of Beaufort Street with Richbourg Road (the chord of which is S 68-00 E 21.2 feet) to a point; thence with the Southwestern side of Richbourg S 23-00 E 135 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTOR to pay 1958 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and Their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
