FLANDERS

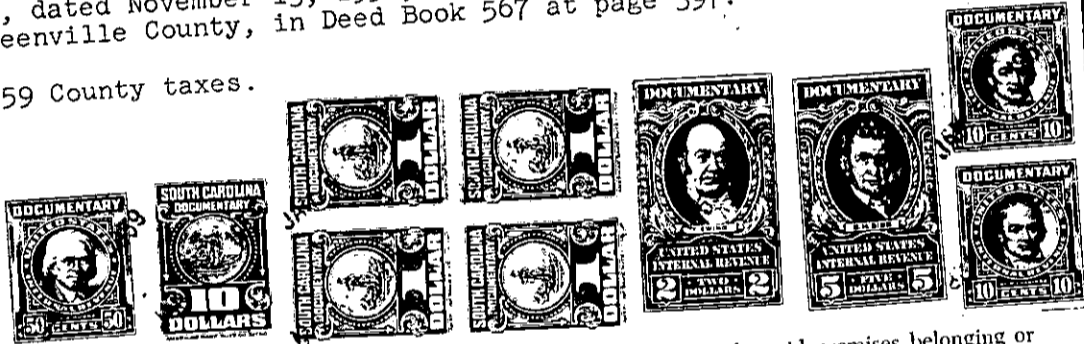
All that certain piece, parcel or lot of land situate, lying and being at the northwestern corner of the intersection of North Warwick Road and Hathaway Circle, in Paris Mountain Township, near the City of Greenville, in Greenville County, State of South Carolina, being known and designated as Lot No. 111 of a subdivision known as Stratford Forest, and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book KK at page 89, the following metes and bounds:

BEGINNING at an iron pin on the western side of North Warwick Road at the joint front corner of Lots Nos. 111 and 112 and running thence with the line of Lot No. 112 S. 80-10 W. 210 feet to an iron pin at the joint rear corner of Lots Nos. 111, 112, 116 and 117; thence with the line of Lot No. 117 S. 19-37 E. 260.8 feet to an iron pin on the northern side of Hathaway Circle; thence with the northern side of Hathaway Circle N. 74-19 E. 194.1 feet to an iron pin; thence with the curve of the intersection of Hathaway Circle and North Warwick Road, the chord of which is N. 25-25 E. 39.5 feet to an iron pin on the western side of North Warwick Road; thence with the western side of North Warwick Road N. 23-30 W. 210 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants applicable to Stratford Forest" recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 578 at page 1 and to drainage and utility easements, if any, affecting said lot.

This is a portion of the property conveyed to the grantor herein by deed of Furman University, dated November 13, 1956, and recorded in the Office of the R.M.C. for Greenville County, in Deed Book 567 at page 397.

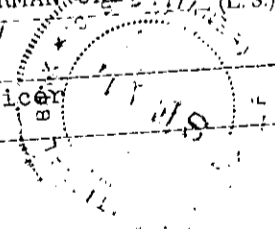
