to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Sara Crim, her Heirs and Assigns forever:

All that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in Austin Township, County of Greenville, State of South Carolina, being known and designated as Lot #34 of B. F. Reeves Subdivision in accordance with Plat made by H. S. Brockman, dated September 14, 1958, and to be recorded in the R. M. C. Office for Greenville County, and being more fully described according to said plat, to-wit:

BEGINNING at an iron pin on the eastern corner of Franklin Avenue and Reeves Drive and running thence along Reeves Drive S. 20-50 E. 193.2 feet to iron pin; thence N. 49-29 E. 135.5 feet to iron pin; thence N. 40-31 W 181 feet to iron pin on Franklin Avenue; thence along Franklin Avenue S. 50-14 W. 69.6 feet to an iron pin, being point of beginning.

This conveyance being subject to all of the restrictions and conditions as contained in the Restrictions recorded in Deed Book 601, Page 35 and reference to said Restrictions are incorporated as a part and parcel of this deed.
