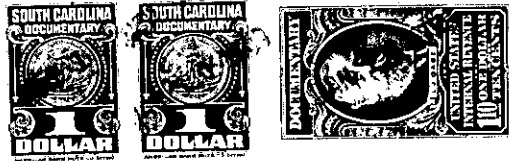
That DERBY HEIGHTS INC., A corporation in the State aforesaid,
