Know All Men by These Presents:

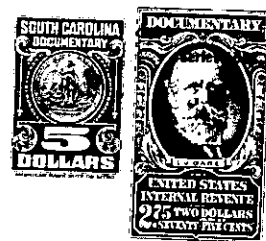
That I, Norma Harris
