That in consideration of the sum of one dollars and partition of property in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Mary Sue LaBoone Mayfield, her heirs and assigns forever:

All of that certain piece, parcel or tract of land in Greenville County, State of South Carolina, near Gantt Station, being shown as Tract No. 3 on plat of property entitled Property Plat of W. F. LaBoone Estate recorded in the R. M. C. Office for Greenville County in Plat Book SS at page 97, and having the following metes and bounds according to said plat:

BEGINNING at a point in the center of Murrell Drive joint front corner of Tracts Nos. 2 and 3, ( iron pin being located on joint line of Tracts Nos. 2 and 3 at distance of 27 feet from the beginning point ); and running thence along the center of Murrell Drive N. 67-18 E. 258.7 feet to a point in the center of Murrell Drive; thence continuing along the center of Murrell Drive, N. 14-12 E. to point on line of Poplar Valley Property (iron pin being located on line in easterly direction 12 feet from said point); thence S. 32-35 E. 99.7 feet to an iron pin; thence along line of Earle property, S. 32-35 W. 296.5 feet to an iron pin; thence N. 58-58 W. 219.5 feet to the beginning corner.

This is a portion of the same property conveyed to W. F. LaBoone by James Fegaly by deed recorded in the R. M. C. Office for Greenville County in Deed Book 268, at page 16; and the grantors and the grantee are all heirs at law of the said W. F. LaBoone. Also see deed recorded in the R. M. C.
