HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Edd Davis and Eula W. Davis

"All those certain lots of land situated in Chick Springs Township,
County and State aforesaid, being known and designated as Lots Nos. 26 and
27 in what is known as Woodland Heights, property of the I. M. Wood Estate
as shown on a subdivision and plat of same made by H. S. Brockman, Reg.
Surveyor, dated October 28, 1955, said plat being of record in the RMC.
Office for Greenville County in Plat Book GG, Page 151, and having the
following metes and bounds and courses and distances as shown by said plat,
to-wit:
