Know All Men by These Presents:

That I, WM. R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND FIFTY AND NO/100-----(\$1,050.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ROSA LEE B. COLEMAN, Her Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, near Mauldin, and being known and designated as Lot Number 48 of a subdivision known as Glendale, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book GG at Pages 32-33, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Drury Lane at the joint front corner of Lots 48 and 49 and running thence N 11-16 E 155 feet to a point at the joint rear corner of Lots 48 and 49; thence S 78-44 E 135 feet to a point on the Western side of Bon Air Street at the rear corner of Lot 48; thence with the Western side of Bon Air Street S 11-16 W 130 feet to a point; thence following the curvature of the Northwestern intersection of Drury Lane with Bon Air Street (the chord of which is S 56-16 W 35.3 feet) to a point; thence with the Northern side of Drury Lane N 78-44 W 110 feet to the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
