Know All Men by These Presents:

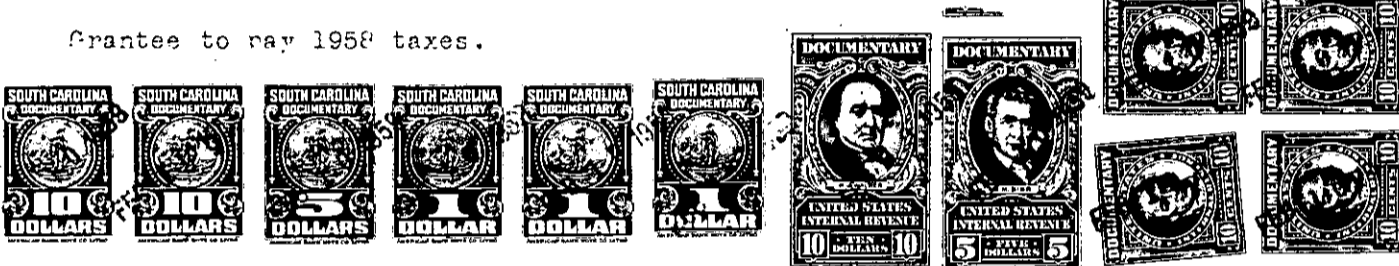

JONES ... in the State aforesaid, in consideration of the sum of Thirteen Thousand Seven Hundred and No./100 (\$13,700.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BEN D. HARVEY, his heirs and assigns forever:

ALL that lot of land situate on the North side of Azalea Court near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 23 on plat of Pleasantburg Forest, made by Dalton & Meves, Engineers, August, 1956, recorded in the RMC Office for Greenville County, S. C., in Flat Book "GG", page 163, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Azalea Court at joint front corner of Lot 22 and 23 and running thence along the line of Lot 22 N. 10-41 E. 210.5 feet to an iron pin; thence S. 78-22 E. 70 feet to an iron pin; thence with the line of Lot 24 S. 5.08 W. 196.2 feet to an iron pin on the North side of Azalea Court; thence along the curve of Azalea Court (the chord being N. 88-16 W. 90 feet) to the beginning corner.
