Sidney Garrett in the State aforesaid, in consideration of the sum of One and No/100 (\$1.00) and love and affection DOLLARS, for my son to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Thomas Dewey Garrett, his Heirs and Assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in the Town of Mauldin, State of South Carolina, County of Greenville, on the southern side of Pleasantdale Drive, being known and designated as Lot No. 3 in property of Grantors in accordance with Plat dated April, 1955 made by R. E. Jordan, and being more fully described in accordance with said Plat, to-wit:

BEGINNING at an iron pin on the southern side of Pleasantdale Drive, joint front corners of lots 3 and 4 and running thence S. 13-15 E. 152.6 feet to iron pin; thence S. 78-58 W. 90 feet to iron pin; thence N. 13-15 W. 149 feet to iron pin on southern edge of Pleasantdale Drive; thence along said Street N. 76-45 E. 90 feet to point of beginning.
