to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Analane C. Gibson, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, shown as lot # 33, on a plat of College Heights prepared by Dalton & Neves, recorded in Plat Book P at Page 75, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Princeton Avenue, joint front corner of lots # 32 and 33, and running thence with the line of said lots, N. 33-10 W. 150 feet to an iron pin; thence S. 56-50 W. 75 feet to an iron pin; thence S. 33-10 E. 150 feet to an iron pin on Princeton Avenue; thence with Princeton Avenue, N. 56-50 E. 75 feet to the beginning corner.

This conveyance is made subject to building restrictions recorded in Deed Book 297 at Page 218, and Book of Deeds 393 at Page 429.

As a part of the consideration for this deed the grantee assumes and agrees to pay a balance due of \$6688.23 on a mortgage held by First Federal Savings & Loan Association.
