to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said HOWARD C. DODSON and ETHEL W. DODSON, Their Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, near Travelers Rest, and being known and designated as Lot Number 25 as shown on a revised map of Lots Numbers 34 through 47 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 113, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Toler Road at the joint front corner of Lots 25 and 26 and running thence S 03-00 W 190 feet to a point at the joint rear corner of Lots 25 and 26; thence N 87-00 W 95.5 feet to a point on the Eastern side of Williams Road at the joint rear corner of Lots 24 and 25; thence with the Eastern side of Williams Road due North 91.4 feet to a point; thence continuing with the Eastern side of Williams Road N 12-15 E 100 feet to a point at the Southeastern intersection of Toler Road with Williams Road; thence with the Southern side of Toler Road S 87-00 E 84 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
