Know All Men by These Presents:

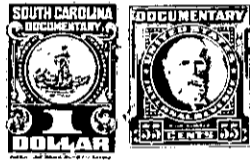

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Joseph P. Williams and his heirs and assigns forever:

All of that certain parcel or lot of land situated on the northside of Milford Church Road and the east side of Joan Street, near Milford Baptist Church, Oneal Township, Greenville County, State of South Carolina, and being Lot No. 23 of the property of W. E. Bannister according to survey and plat by W.P. Morrow, Registered Surveyor, and having the following courses and distances, to-wit:

BEGINNING at an iron pin in the center of the Milford Church Road at the intersection of Joan Street, and running thence along the east side of said street, N. 17-10 W. 168 feet to an iron pin, corner of Lot No. 22; thence along the line of Lot No. 22, N. 83-03 E. 207.9 feet to an iron pin on the line of the Sloan property; thence S. 4-00 W. 168 feet to an iron pin in the center of the Milford Church Road; thence along the said road, S. 83-03 W. 147.5 feet to the beginning corner.
