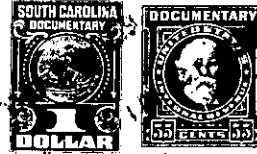

Walker and Yvona M. Walker, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 66, as shown on a plat of Marion Grove subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 137, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Marion Street joint front corners of Lots Nos. 65 and 66 and running thence along the line of said lots, N. 18-45 W. 212.8 feet to iron pin line of Lot 67; thence running with line of said lot, S. 85-58 E. 143.8 feet to iron pin on Holly Drive; thence running with said Drive, S. 4-02 W. 144 feet to iron pin; thence running, N. 37-38 E. 44 feet to iron pin; thence running with Marion Street, S. 71-15 W. 40 feet to iron pin at point of beginning.
