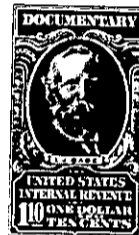

All that piece, parcel or lot of land in or near the Town of Simpsonville, Austin Township, Greenville County, State of South Carolina, lying to the east of the C. & W. C. Railroad and being lots Nos. 49 and 50 in a subdivision now known as Forest Park and formerly known as Gresham Park. This being part of the property conveyed to me by William C. 3. No livestock such as cattle, horses, hogs, goats or chickens shall be maintained, housed or pastured on this property.
4. Any residence must be constructed at least 35 feet from the street.
