HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said John Charles Barnett, Laurie Farr Moseley, John J. White and
Lowell H. Tankersley
ALL that certain piece, parcel or lot of land situate, lying and being in Glassy Mountain Township, County of Greenville, State of South Carolina
on the head waters of the South Pacolet River on top of Glassy Mountain,
containing 215 acres, more or less, as shown on a plat of the Glassy Rock Mountain Development prepared by H. L. Dunahoo, Surveyor, on October
9 - 13, 1950, and having according to said plat the following metes and bounds, to-wit:
