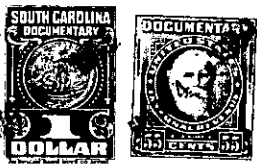

Paul Rice, his heirs and assigns:

All that tract or lot of land in Cleveland Township, Greenville County, State of South Carolina, known and designated as Lot No. 6 in the subdivision known as Wonderland Range, according to survey and plat made by W.J. Riddle, November 1951 and of record in the R.M.C. Office for Greenville County in Plat Book "BB" at page 29.

This deed is subject to all recorded restrictions, right-of-ways, easements, water lines and other recorded covenants pertaining to Wonderland Range.

A ten (10) foot right-of-way is hereby reserved for the purpose of ingress and egress to Lot No. 6-A across that portion of Lot No. 6 adjoining Lot No. 5.

Grantee to pay 1959 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
