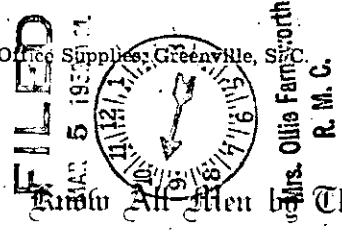

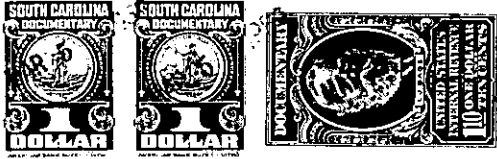
That we, Eddie W. Gregory and Minnie B. Gregory in the State aforesaid,

All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, designated as Lot No. 9 on a plat of Section 2, Fairfield Acres, recorded in the R. M. C. Office for Greenville County in Plat Book "FF" at page 459, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Lermann Drive at the joint corner of Lots #8 and #9 and running thence along the line of said lots N. 2-25 E. 125 feet to an iron pin; thence along the rear line of the property conveyed herein S. 87-35 E. 75 feet to an iron pin; thence along the line of Lots #9 and #10 S. 2-25 W. 125 feet to an iron pin on Lermann Drive; thence along the northern side of Lermann Drive N. 87-35 W. 75 feet to the point of beginning.

This property is subject to the restrictive covenants recorded in Deed Book 563 at page 304, and is a portion of the property described in Deed Book 283 at page 424. The grantee to pay 1959 taxes.
