Know All Men by These Presents:

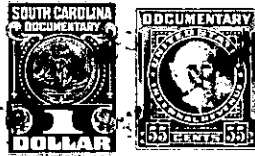

All that piece, parcel or lot of land being known and designated as Lot #126 as shown on a plat thereof entitled Conestee Plat #2 prepared by Madison H. Woodward, Engineer and recorded in the RMC Office for Greenville County in Plat Book T at pages 383 and 384.

Said lot having such metes and bounds as shown thereon.

That the lands shall not be sold, rented or totherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand (\$2,000.00) Dollars, shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.

This being a portion of the property conveyed to the grantor herein by deed recorded in Book 531 at page #246.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
