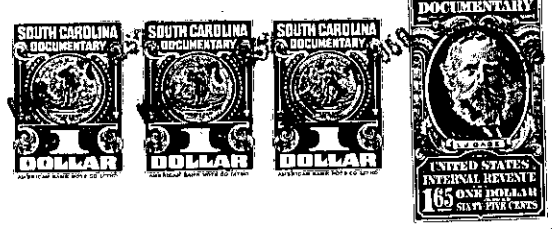
Know All Men by These Presents:

in consideration of the sum of FIFTEEN HUNDRED AND NO/100 (\$1500.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. W. Strickland, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #82 and the southern one-half of Lot #81 of Glendale Heights, as shown by a plat thereof made by J. Mac Richardson, February, 1958 and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 143, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Knox Street at the joint corners of Lots #82 and #83 and running thence along the western side of Knox Street, N. 6-45 W., 70 feet to a pin at the corner of Lot #81; thence continuing with the western side of Knox Street, N. 6-45 W., 35 feet; thence S. 83-15 W., 139.5 feet more or less to a pin in the subdivision property line; thence with the subdivision property line, S. 8-28 E., 35 feet, more or less to a pin at the corner of Lot #82; thence still with the subdivision property line S. 8-28 E., 70.03 feet to a pin at the rear corner of Lot #83; thence with the line of Lot #83, N. 83-15 E., 137.4 feet to the point of beginning.
