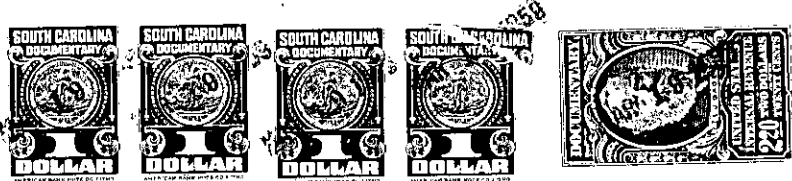
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. M. Brown, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as lot #54, part of Thornwood Acres, property of Williams Land Company, Inc., according to plat by C. C. Jones, Engineer, dated November 1958, plat of which is recorded in the R. M. C. Office for Greenville County, In Plat Book MM, page 59, and according to said plat, having the following metes and bounds:

BEGINNING at an iron pin at the northwest intersection of Brushy Creek Road and Drexmoore Drive, at the joint corner of lots #54 and #55, running thence along the line of these lots, S. 32-27 W. 138.1 feet to an iron pin; thence S. 49-03 E. 24.7 feet to an iron pin; thence S. 58-23 E. 89.5 feet to an iron pin on the northwestern side of Drexmoore Drive; thence along the northwestern side of Drexmoore Drive, N. 32-53 E. 115 feet to an iron pin at an intersection; which intersection is curved, the chord of which is N. 12-46 W. 35.5 feet to an iron pin on the southwestern side of Brushy Creek Road; thence along the southwestern side of Brushy Creek Road, N. 57-33 W. 90 feet to an iron pin, point of beginning.
