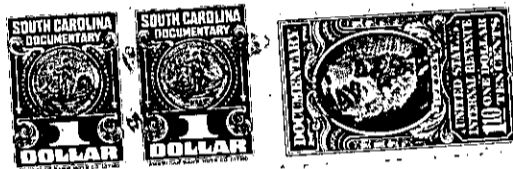
That Clara Camp Stansell in the State aforesaid,

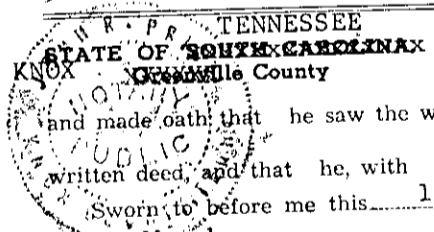
